Dear Members:

I would like to invite membership of the Polish American Congress - Northern California Division (PAC-NCD) to attend the Division's Annual Meeting and Elections on Sunday, September 10th at 3PM at the Holiday Inn at 4200 Great America Parkway, Santa Clara, CA 95054.

The Nominating Committee of the Division: Dr. Piotr Moncarz - Chairman, Dr. Elizabeth Cathers - member, Mr Jakub Urban - member, recommends that the current members of our PAC Division Executive Board to be elected to serve for the next term with an addition Mr. George Slawek for a position of the Second Vice President:

- President - Mr. Antoni Zukowski
- First Vice President - Mr. Waldemar Glodek
- Second Vice President - Mr. George Slawek
- Secretary - Mr. Sebastian Zurek
- Treasurer - Mrs. Zofia Shicker

We have to call this elections meeting again, since our previously scheduled Annual Meeting and Elections of July 9th, 2006 at the Polish Club in San Francisco was disrupted at the very beginning by non members under the leadership of Mr. Zdzislaw Zakrzewski and his associates from Mr. Edmund Lewandowski's private internet portal - **PoloniaSF/e-mail list** who came to that meeting and demanded to have voting rights equal to the PAC-NCD member organizations who paid their dues continuously through many years and are all registered with the California Secretary of State or are lodges of the Polish American national organization.

I made several attempts to bring that meeting to order and to proceed according with the meeting agenda at that time. Unfortunately, I did not succeed and had to declare that meeting as unruly, out of order and terminated to be conducted at a later date as now being stated to be on Sunday, September 10th.

After I terminated the official meeting and left, Mr. Zdzislaw Zakrzewski took over and considered himself to be a chairman of the Election Meeting. While pretending to be a chairman, he also run for the office of the President of the Northern California Division and declared himself to be a winner in the false and rigged elections. Voting mandates were also given by Mr. Zdzislaw Zakrzewski to the delegates from Lewandowski's bogus organization, PoloniaSF, and mostly non members of the PAC-NCD were elected to the bogus PAC-NCD Executive Board.

Obviously, current PAC-NCD Executive Board under my leadership filed a protest with the PAC National Office in Chicago and we submitted there full documentation of Mr. Zakrzewski and his associates misconduct and the elections fraught by them plus audio records of the Annual Meeting of July 9th. After review by the National Office, Mr. Zdzislaw Zakrzewski and his associates, mostly non members of the PAC, were not accepted and the new elections are being called now to be conducted again by our Division on September 10th, 2006. I would like to explain to membership that Mr. Edmund Lewandowski is the owner of the bogus organization, PoloniaSF which does not qualify to be a member of any Division of the PAC. In its true nature, this is nothing else than just privately owned by him internet portal with an associated e-mail list which he is using frequently as a proxy to spread misinformation and to attack and subvert public Polonia's organizations. A good example of this is what happened at the recent PAC-NCD Annual Meeting of July 9th. He is also using PoloniaSF all the time to attack leadership of the Polish Club and to spread misinformation about the nature of his groundless and frivolous law suite against the Polish Club in San Francisco which he lost, but it cost Polonia's public organizations owning the Polish Club ~\$380,000 in legal defense and court fees.

It is amazing and disturbing how closely Mr. Zakrzewski and some other Polam's FCU directors are associated with Mr. Lewandowski's demagoguery and in effect are politicizing and undermining public trust in this banking institution by continuously attacking and spreading insinuation about the leadership of the Polam's sponsoring organization which is the Polish American Congress - Northern California Division.

Please judge it yourself how proper it is; Mr Zakrzewski - Polam's Board of Directors Secretary proclaims himself to be a president of the PAC-NCD, nominates Treasurer who is not the PAC member and his wife Zofia Zakrzewska - President of Polam sent me a letter that our PAC Division banking accounts at Polam are blocked.

And next few questions to Mr. Zakrzewski, should Secretary of the Polam Board and some other Polam's Board members run for positions on the Board of the Polam's sponsoring organization -

PAC-NCD without being nominated by the PAC-NCD Nominating Committee??? PAC-NCD also would like to know when all the references that Polam FCU is an Polish American organization were removed from the Polam's Bylaws. Should we qualify at all any organization which explicitly removed from its Bylaws that is Polish American one to be eligible for membership in the PAC-NCD???
